### "Gobiin Noyon Nuruu" LLC becomes MSE's member

By the meeting of 4th April 2013, Mongolian Stock Exchange Board of Directors admitted "Gobiin Noyon Nuruu" LLC as a member of Mongolian Stock Exchange. Consequently, the number of members of MSE has reached 83.

## "Golomt Securities" LLC starts trading remotely from their own offices

Mongolian Stock Exchange implemented several important activities for strengthening the capital market of Mongolia such as introducing the Millennium IT integrated system together with T+3 Clearing and Settlement system on July 02, 2012 since the exchange had signed the "Master Services"

Agreement" on developing domestic capital market with the State Property Committee of Mongolia and London Stock Exchange Group.

The exchange has previously reported that technological solution and infrastructure has been set up for remote trading which enables Mongolian brokers to implement daily securities trading in their own offices which is one of the advantages of the Millennium IT system.

The brokerage firm, "Golomt Securities" LLC was the first market participant signing the agreement on April 1, 2013 and started trading remotely from their offices from April 4, 2013. Trading in their offices brokers will have the advantage of providing time efficiency and prompt information supply for investors.





From 1st to 15th of April 2013 3.4 million shares of 65 companies' worth MNT 1.1 billion have been traded through 11 trading sessions.

During the time the most active stocks were "HBOil" JSC / MNT 512.7 million/, "Talkh-Chikher" JSC / MNT 227.5 million/ "BDSec" JSC /MNT 98.1 million/.



#### Trading Report for 1Q 2013

#### Stock trading

By March 29, 2013, a total of 110 companies' 14.2 million securities had been traded for MNT 8.7 billion through 61 trading sessions. In the first quarter of the year, the share price of 53 out of 110 companies increased, while the share price of 44 companies declined, albeit 13 companies share price were constant.



#### **Block Trading**

In the reporting period, a total of 6.2 million securities of 4 companies (Moninjbar, Darkhan Nekhii, Gobi and Mongolia Development Resource) were traded for MNT 4.4 million in block. An amount of the block trading takes 50.6

On March 29, 2013, TOP-20 index closed at 15,542.24, slip 12.5% from the beginning of the year.

#### Market capitalization
